#### ***Computer and Information Science***

##### Brief Justification

Fees would support lab spaces Klamath B26, which is an instructional space for scheduled classes for CIS students, and Deschutes 100, a study lab space. There are a total of 42 iMacs in use by students between these two spaces. Each iMac costs approximately \$2,300 each based on recent purchase history. Currently 6 per lab (12 total) are cycled out annually at a cost of \$27,600 approximately. Course fees estimates to be \$26,120 annually to cover replacement of iMacs.

##### *Environmental Studies*

###### Brief Justification

To cover maintenance and repairs to the field equipment (solar pathfinders, weather meters, illuminometers, anemometers, thermometers, hygrometers, airflow bubbles and data loggers), average cost is \$100 per year for replacement parts, batteries and repairs. Fee includes cost for a kit of parts for a competition consisting of cardboard, clear acrylic sheets, duct tape, and glass beads that cost approx. \$18 in 2019.

Kit of parts \$6 x 24 per student = \$144 for kits and \$96 for maintenance = \$10 per student
